

## Bel Fuse Inc. Announces Regular Quarterly Cash Dividend on its Class A and Class B Shares

Cash dividends for Class A and Class B common shares are payable on February 1, 2018 to shareholders of record on January 15, 2018.

Bel currently has approximately 12,034,000 common shares outstanding, of which 2,175,000 are Class A common shares and 9,859,000 are Class B common shares.
