Cash dividends for Class A and Class B common shares are payable on November 1, 2018 to shareholders of record on October 15, 2018.

Bel currently has approximately 12,013,000 common shares outstanding, of which 2,175,000 are Class A common shares and 9,838,000 are Class B common shares.
