

Bel Fuse Inc. Announces Regular Quarterly Cash Dividend on its Class A and Class B Shares

(NASDAQ:BELFA) and (NASDAQ:BELFB) today announced that its Board of Directors has declared regular quarterly cash dividends of \$0.06 per share on the Company's Class A common shares and \$0.07 per share on the Company's Class B common shares.

Cash dividends for Class A and Class B common shares are payable on November 1, 2019 to shareholders of record on October 15, 2019.

Bel currently has approximately 12,317,000 common shares outstanding, of which 2,175,000 are Class A common shares and 10,142,000 are Class B common shares.
