Cash dividends for Class A and Class B common shares are payable on February 1, 2021 to shareholders of record on January 15, 2021.

Bel currently has approximately 12,359,000 common shares outstanding, of which 2,145,000 are Class A common shares and 10,214,000 are Class B common shares.
