Cash dividends for Class A and Class B common shares are payable on April 29, 2022 to shareholders of record on April 15, 2022.

Bel currently has approximately 12,522,000 common shares outstanding, of which 2,145,000 are Class A common shares and 10,377,000 are Class B common shares.
