(NASDAQ:BELFA) and (NASDAQ:BELFB)** today announced that its Board of Directors has declared regular quarterly cash dividends of \$0.06 per share on the Company's Class A common shares and \$0.07 per share on the Company's Class B common shares.

Cash dividends for Class A and Class B common shares are payable on May 1, 2025 to shareholders of record on April 15, 2025.

Bel currently has approximately 12,540,000 common shares outstanding, of which 2,115,000 are Class A common shares and 10,425,000 are Class B common shares.
