

Bel Fuse Inc. Announces Regular Quarterly Cash Dividend on its Class A and Class B Shares

JERSEY CITY, NEW JERSEY, November 19, 2007 . . . BEL FUSE INC. (NASDAQ:BELFA) & (NASDAQ:BELFB) today announced that its Board of Directors has declared regular quarterly cash dividends of \$0.06 per share on the Company's Class A common shares and \$0.07 per share on the Company's Class B common shares.

Cash dividends for Class A and Class B common shares are payable on February 1, 2008 to shareholders of record on January 15, 2008.

Bel currently has approximately 11,800,000 common shares outstanding, of which 2,500,000 are Class A common shares and 9,300,000 are Class B common shares.
