Bel Fuse Inc. Announces Regular Quarterly Cash Dividend on its Class A and Class B Shares

Cash dividends for Class A and Class B common shares are payable on May 1, 2017 to shareholders of record on April 14, 2017.

Bel currently has approximately 12,027,000 common shares outstanding, of which 2,175,000 are Class A common shares and 9,852,000 are Class B common shares.
