

## Bel Fuse Inc. Declares Regular Quarterly Cash Dividend on its Class A and Class B Shares

Bel currently has approximately 11,478,000 common shares outstanding, of which 2,703,000 are Class A common shares and 8,775,000 are Class B common shares.
