Cash dividends for Class A and Class B common shares are payable on August 1, 2005 to shareholders of record on July 15, 2005.

Bel currently has approximately 11,478,000 common shares outstanding, of which 2,703,000 are Class A common shares and 8,775,000 are Class B common shares.
